ANNUAL MEETING SUMMARY Terry Clements

The WSBRS annual meeting was held on Tuesday, May 7th in Yakima. Eight members, the current board and the executive secretary attended the meeting. The 2019-2020 budget was reviewed and approved. Several bylaws changes were presented. A change to Article IV would allow for director election ballot options to include email or other electronic ballots in addition to mail ballots. A change to Article VIII would reduce the number of mailings of CEU reports from two to one annually and add the option of requesting a report at any other time. Both bylaws changed were approved unanimously. Other items discussed were the use of REHS as an option to members, the need to update the webpage and possible ramifications of the administration of the RS examination being limited to electronic format only starting in 2020. The group agreed that all these issues should receive further board attention during the coming year.

REGISTERED SANITARIAN EXAM

The RS exam can currently be arranged at a variety of times and locations. This will continue through 2019. Beginning in 2020 we will be administering the REHS/RS Exam through Pearson Vue testing sites. Please contact the Executive Secretary for an Application Packet and/or to schedule an exam in 2019. The Exam and Reciprocity Application packets are available for download from our website. The WSBRS has exam proctors in Everett, Bremerton, Seattle, Yakima, Tacoma, and Spokane. More information will be provided regarding exam testing in 2020.

Per the by-laws, CEU credits/courses remain on your record for 3 years. Please note your current CEU total. If your total is below 3.0 and you have been a member over 3 years, you will need CEU's prior to renewing

your registration this July. DO NOT return your membership renewal if you do not meet the minimum CEU requirements. It will be returned.

CEU application forms are available for download from our website. All applications must be sent to the Executive Secretary for processing. It is very important to include all necessary supporting documentation (i.e. timed agenda, certificate of completion showing contact hours or CEU's awarded, college transcripts or letter of attendance). Please note that Appendix B of our By-laws requires applications for CEU's to be accompanied by a conference agenda with times you attended listed and/or highlighted. This is important information for the CEU Committee members who review the application. Incomplete CEU applications may be returned for clarification. You may submit for CEU application and supporting documentation via USPS mail or email.
